#### Reminders:

The procedure for reminders is completely rewritten and has the same look and feel as the invoicing module, making it much more user friendly. Reminders can be grouped by debtor, cover letter or account manager.

This new procedure will work with all current layouts we developed for our clients.

## Intercompany journal entries:

This procedure is now much more user friendly and process driven. The user will be guided in steps through these bookings to select the correct bookkeeping, general ledger and daybook.

Previous decisions are saved but can be altered during the process.

The menu option in Maintenance – Financial is removed.

### **Currency maintenance:**

The currency screen is enhanced with several functions to filter on year, sort the dates and resize the screen.

#### **Accounting:**

- A check is added to daybook Debtors to check if a document number for a debtor is used in another page.
- Currency code UGX for Uganda shilling is added.

#### Time and invoicing:

  regarding topic: Supervisor utilities > Custom-made menus.
   Mill7 does not have to be restarted when you edit the Custom menu by option "Adjust custom menu"
  anymore.
- The general report on Rights is improved, please read the description in the report.
- Setting rights for a complete list of client bookkeepings is enhanced.
   Two buttons have been added to set all read or write rights at once.

#### **Accounting:**

- Automatic completion while entering a general ledger or description in a journal is added making entering data easier. The interval can be set in the Settings – Trust.
- Authorization of automatic payments is added. By activating the authorization in the Settings Book –
  Other, users can be authorized by the rights system to authorize outstanding invoices in the screen
  Creditors Outstanding invoices.
- The VAT amount can be calculated in a second currency.
   By setting the currency to Euro in the Settings Book Other, the VAT will be calculated in a different currency. The data is saved in the Ctrl+K fields of the journal making it possible to create a Tax declaration NL and revaluate the VAT, when set to Euro.
- The field cost center is added to the creditors as default for the opposite accounts in an invoice.
   The cost center is filled in automatically at the opposite accounts. The cost type of the general ledger must be set.
- The general ledger journals in an invoice can be calculated automatically in the currency of the invoice. Activate option "Calculate cost and income in currency invoice (Ctrl+K info)" in Settings – Book – Other.
- Three new fields have been added to general ledgers that can be used for reporting purposes. In the report module these fields can be used instead of the Mill7 account number for external reporting purposes.

#### Improvements in automatic payments:

- The currency of the creditor bookings are now always in the bookkeeping currency.
- The amount in the creditor currency is automatically saved in the CTRL-K fields of the creditor journal.
- The Euro amount is saved in the general ledger journals in the Ctrl+K info when the bookkeeping currency is not in Euros.

### Improvements accounting:

- When both settings "Show last book year" and "Show foreign currency" are activated, the foreign currency amounts of last book year are also presented in the Trial balance.
- The invoice date in the outstanding invoices was empty when only the payment existed.
   In this case the date will be set to the payment date.
- A check is added to make sure that the currency rate cannot be 0 in a journal entry.
- A check is added to make sure that the currency of the last book year is the same as the current book year when the setting "Show last book year" is activated in the Trial balance screen.

- A check is added to the creation of a new relation code to make sure that a code can only be used once for a person and a company.
- Import journals: A check is added on the setting "Do Not allow booking outside period or book year".
- Import journals: The item "Quantity" is added to the importing of journal entries.
- Creating a new bookkeeping: The cost centers and cost types are now also copied to the new bookkeeping with option "Copy basis data excluding relations".
- A check is added on the creation of a Clieop03 file. When the creation of the file is not successful the process stops.
- The column Stat.no. is added to the automatic payments screen and the screen Creditors Outstanding invoices.
- Currency: The currency GHS Ganesh Cedi Ghana is added to the currency list.
- The name of the debtor or creditor is now saved in the description of the automatic VAT journal entry.
- The calculation of the period number is improved for bookkeeping with an extended bookyear that runs over 2 years.
- The table number of exchange rates can now have a length of 8 characters long.
- The field bank number in the screen "debtors collection" and "creditors automatic payments" is checked by the 11 test when this option is set in the settings Relations.

#### Portfolio:

- The interest on a bond was recalculated too often. The interest will only be adjusted when you change the original booking in the bond. Recalculating Portfolio will not cause to the interest to be recalculated anymore.
- The selection screen in the maintenance of the stock has improved search options regarding Cusip, Isin and Sedol codes.
- A new report "Portfolio stock" is added to the report module.

#### Relations:

- A new screen is added for Events in menu Bookkeeping > Relations > Events.
- 24 new free fields can be added to persons. These fields can be configured from menu Supervisor Relations. For more information please read our Mill7 help topic: Supervisor utilities > Free fields
  persons.
- The key combination Ctrl+F can now be used in the debtor and creditor screen.
- Copy address to clipboard is divided in two options: "Copy postal address to Clipboard" and "Copy visiting address to clipboard".
- Switching between companies, persons and relation management is improved.

## **Relation management:**

- The field "First names" is moved to the tab General of persons.
- A new field named "2<sup>nd</sup> nationality" is added to the tab Other of persons
- A selection on Account manager is added to the client filter in Relation management.
- The report "Relation management query extended" is improved.
- The setting "print code table instead of description" that can be set in the relation management query now also works with the field country for both persons and companies.
- When inserting a field in a relations query the new line wasn't inserted properly into the selection, this is solved.
- The keys for saving and deleting in Relation Management stopped reacting after clicking in the data list, this is solved.

#### Invoicing:

The debtor code can now be included in the filename of the invoice when email is selected.
 This is set in the Settings – Invoice – Email.

### Time:

#### Release Notes

- Automatic completion of data entry is added.
- The setting "Only register direct time to clients" and "only register indirect time to service companies" did not function properly in the option "Spread time over debtors".
- The option "Spread time over debtors" is improved, the time was spread correctly but the amount was not. This is solved.

# **New relation management fields:**

- Field number 28 is added to fees (F117). By using this field you can indicate if the fee is invoiced afterwards. Standard fees are invoices in advance. The text on the invoice will change accordingly.
- Field number 27 is added to Meetings (F122). This field included a popup table.

# **New rights:**

- New general right "Read tab page free fields persons".
- New general right "Change tab page free fields persons".
- New general right "Authorize payments creditor".

# **New settings:**

- "VAT currency" in Settings Book Other, to calculate VAT in a second currency.
- "Calculate cost and income in currency invoice (Ctrl+K info)" in Book Other.
- "Authorize invoices creditors before payment" in *Book other*.
- "Link to external DMS" and "Wait on external DMS" in *Trust Documents*.

  This setting is to link to documents in an external DMS document management system. The software needed for this linking is developed on a custom bases.
- "Interval autocomplete in milliseconds (default 300)" in Trust general.
